1. IDENTIFICATION OF THE WEBSITE OWNER

2. APPLICABLE REGULATORY FRAMEWORK

This Legal Notice governs access to and use of the <https://meketid.com> website (hereinafter, the "Website") and is governed by Spanish law and applicable European Union regulations, in particular:

- Spanish Law 34/2002 (LSSI-CE);
- Regulation (EU) 2016/679 (GDPR);
- Spanish Organic Law 3/2018 (LOPDGPD);
- RDL 1/2007 (TRLGDCU - Spanish General Consumer Protection Act); Spanish Intellectual Property Act (RDL 1/1996).

3. PURPOSE OF THE LEGAL NOTICE AND ACCEPTANCE

This Legal Notice governs the general conditions for access, navigation and use of the Website by any person who accesses it (hereinafter, the "Visitor"). Access to the Website confers Visitor status and implies acceptance of the conditions set out in this Legal Notice.

Use of the Website is free of charge and does not require prior registration. This Legal Notice does NOT govern the contracting of the MEKET service, which is performed exclusively from the app.meketid.com web application, governed by its own Terms of Use, Privacy Policy and specific Consents.

4. NATURE OF THE INFORMATION PUBLISHED ON THE WEBSITE

The Website is informational and promotional in nature. Its purposes are:

- to present the MEKET service and its features;



- to display the available modalities and their public reference prices for orientation purposes;
- to enable voluntary registration on the wait list of persons interested in the launch or in product news;
- to provide access to the legal texts applicable to the service;
- to offer a contact channel with the owner.

4.1. Informational nature of prices

The prices shown on the Website are merely informational and indicative. The final prices, the modalities in force, the contracting conditions, applicable taxes and the currency of charge are shown clearly, completely and bindingly on the contract screen of the app.meketid.com application, before payment is formalised, in accordance with Articles 97 et seq. of the TRLGDCU.

MEKET reserves the right to modify the informational prices on the Website at any time without prior notice. Contracting is always governed by the price and conditions in force at the time of payment formalisation in the application.

4.2. Service access and contracting

The MEKET service is accessed and contracted exclusively from the progressive web application app.meketid.com. Registration, account creation, emergency profile creation and, where applicable, subscription to paid modalities, are performed in that application, subject to the Terms of Use, Privacy Policy, specific Consents and other legal texts of the product.

5. CONDITIONS OF USE OF THE WEBSITE

The Visitor undertakes to use the Website diligently and in accordance with the law, morality, public order and this Legal Notice. In particular, the Visitor undertakes to refrain from:

- using the Website for unlawful, fraudulent purposes or for purposes contrary to the provisions of this Legal Notice;
- introducing or disseminating content that infringes fundamental rights;
- carrying out massive, automated or systematic access to the Website, as well as any data extraction technique (scraping) without express authorisation from the owner;
- introducing malicious software, viruses or any element that may damage the Website;
- reproducing, distributing, transforming or reusing the contents of the Website without authorisation, except in cases legally permitted;
- impersonating the identity of the owner, of MEKET or of any third party.

6. INTELLECTUAL AND INDUSTRIAL PROPERTY

All contents of the Website (texts, photographs, graphics, images, icons, technology, software, source code, graphic design, colour palettes, typography, logos, trademarks, trade names and any other sign susceptible of industrial and commercial use) are protected by intellectual and industrial property rights, owned by the owner of the Website or, where applicable, by third parties who have duly authorised their inclusion.

The MEKET brand, its logo and its graphic identity are property of the owner and are being processed as a registered trademark. Any use, reproduction, distribution, public

Access to the Website does not grant the Visitor any property or exploitation rights over the contents.

The Visitor's access to External Sites is at their sole responsibility.

8. LIABILITY AND AVAILABILITY OF THE WEBSITE

The owner will use best efforts to keep the Website accessible, up-to-date and error-free. However, the owner does not guarantee continued availability of the Website, which may be interrupted for maintenance, updates, technical incidents or other causes beyond the owner's control.

To the maximum extent permitted by applicable law, the owner will not be liable for damages arising from:

- the presence of errors, viruses or harmful elements in the contents, provided the owner has adopted reasonably required technical measures;
- the misuse of the Website by the Visitor or third parties;

In particular, the owner informs that wait list data is managed through the provider Brevio (including the Sibforms tool), which acts as data processor. The purpose is the sending of communications related to the launch of the service and product news, on the basis of the prior consent of the interested party (Art. 21 LSSI-CE and Art. 6.1.a GDPR).

The Website uses cookies and similar technologies in accordance with applicable regulations (Art. 22.2 LSSI-CE). Detailed information is set out in the Cookie Policy of MEKET, accessible separately from the Website.

11. MODIFICATIONS TO THE LEGAL NOTICE

The owner reserves the right to modify this Legal Notice at any time, especially when required by legal, technical, operational or activity-related changes. Modifications will take effect upon publication on the Website.

12. APPLICABLE LAW AND JURISDICTION

This Legal Notice is governed by Spanish law and, where applicable, by European Union law.

For the resolution of any dispute arising from access to or use of the Website, the parties, expressly waiving any other jurisdiction that may correspond to them, submit to the jurisdiction of the Courts and Tribunals of Manresa (Barcelona, Spain).

Notwithstanding the foregoing, where the Visitor has consumer status under the TRLGDCU, the provisions of Regulation (EU) 1215/2012 of the European Parliament and of the Council shall apply, allowing the consumer to bring their claim before the courts of their own domicile or those of the domicile of the owner of the Website.
